

## **MOSCOW SCHOOL DISTRICT NO. 281**

### **LEGAL DESCRIPTION OF THE DISTRICT**

BEGINNING at the SW corner of the SE 1/4 of the NW 1/4 of Sec. 13, Twp. 38 N, R 6 WBM, where it intersects the Idaho-Washington State line; thence north 162 miles to the NW corner of the NE 1/4 of the NW 1/4 of Sec. 25, Twp. 41 N, R 6 WBM; thence east to the NE corner of Sec. 30, Twp. 41 N, R 5 WBM; thence south 2 mile; thence east 2 mile to the center of Sec. 29, said township and range; thence north 2 mile; thence east 1 mile; thence south 2 mile to the center of Sec. 28, said township and range; thence east 1 mile; thence north 2 mile; thence east 2 mile to the NE corner of Sec. 27, said township and range; thence north 1/4 mile; thence east 2 mile; thence south 1/4 mile to the N 1/4 corner of Sec. 26, said township and range; thence east 1 mile; thence south 2 miles through the middle of Sec. 25 & 36, Twp. 41 N, R 5 WBM, to the S 1/4 corner of said Sec. 36; thence west 2 mile; thence south 2 miles; thence east 3 miles to the NE corner of Sec. 17, Twp. 40 N, R 4 WBM; thence south 3 miles to the SE corner of Sec. 29, said township and range; thence east 2 mile; thence south 11/4 miles; thence east 1/4 mile to the NE corner of the SW 1/4 of the NE 1/4 of Sec. 4, Twp. 39 N, R 4 WBM; thence south 1/4 mile, more or less, to the county road; thence NW on the county road to a point where it intersects the north-south centerline of said Sec. 4; thence south to the S 1/4 corner of said Sec. 4; thence west 2 mile; thence south 3 miles to the NE corner of Sec. 29, Twp. 39 N, R 4 WBM; thence east 1 mile; thence south 2 mile; thence east 2 mile to the center of Sec. 27, Twp. 39 N, R 4 WBM; thence south 3/4 mile; thence east 2 mile; thence south 3/4 mile to the SE corner of Sec. 34, Twp. 39 N, R 4 WBM; thence west 1 mile to the SW corner of said Sec. 34; thence north 1 mile; thence west 2 3/4 miles to the NE corner of the NW 1/4 of the NW 1/4 of Sec. 31, Twp. 39 N, R 4 WBM; thence south 1 mile; thence west 1/4 mile; thence south 2 mile to the E 1/4 corner of Sec. 1, Twp. 38 N, R 5 WBM; thence west 1 mile through the center of said Sec. 1; thence south 2 mile; thence west 1 mile to the SW corner of Sec. 2, Twp. 38 N, R 5 WBM; thence south 2 mile; thence west 2 mile to the center of Sec. 10, said township and range; thence north to the N 1/4 corner of said Sec. 10; thence west 3 1/4 miles to the NE corner of the NW 1/4 of the NW 1/4 of Sec. 7, said township and range; thence south 2 mile to the SE corner of the SW 1/4 of the NW 1/4 of said Sec. 7; thence west to the W 1/4 corner of said Sec. 7; thence south to the centerline of Jacksha Road; thence south on the centerline of Jacksha Road to the N boundary line of Sec. 18, said township and range; thence west approximately 2 mile to the N 1/4 corner of Sec. 13, Twp. 38 N, R 6 WBM; thence south 2 mile to the center of said Sec. 13; thence west to the Idaho-Washington state line, the point of beginning.

### **TRUSTEE ZONE NO. 1**

Beginning at the intersection of US Highway 95 and Foothill Road; east and then north on Foothill Road to Idlers Rest Road; east on Idlers Rest Road to Mountain View Road; south on Mountain View Road to West Twin Road; northeast on West Twin Road to Herington Road; south on Herington Road to Moscow Mountain Road; east then north on Moscow Mountain Road to Frink Road; east on Frink Road to Crumarine Road; north then east then south on Crumarine Road to Lyon Road; east on Lyon Road to Robinson Park Road; west on Robinson Park Road to the intersection of Darby Road, Crumarine Road and Robinson Lake Road; southwest on Robinson Lake Road and Robinson Park Road to Olsen Road; north on Olsen Road to Darby Road; west on Darby Road to Mountain View Road; south on Mountain View Road to a point where Mountain View Road departs to the west and the city limits of the City of Moscow continues south; south on the city limits to D Street; west on D Street to Van Buren Street; south on Van Buren Street to 6<sup>th</sup> Street; west on 6<sup>th</sup> Street to Main Street; north on Main Street becoming US Highway 95 to the beginning.

### **TRUSTEE ZONE NO. 2**

Beginning at the intersection of Van Buren Street and D Street; east on D Street to the point where the city limits of the City of Moscow departs to the north; north on the city limits to Mountain View Road; north on Mountain View Road to Darby Road; east on Darby Road to Olsen Road; south on Olsen Road to Robinson Park Road; east on Robinson Park Road and Robinson Lake Road to the intersection of Darby Road, Crumarine Road, and Robinson Park Road; east on Robinson Park Road to Hendrix Road; north and easterly on Hendrix Road to Showalter Road; east on Showalter Road to the eastern district boundary; south on the district boundary to State Highway 8; west on State Highway 8 and Troy Street to Blaine Street; north on Blaine Street to 6<sup>th</sup> Street; west on 6<sup>th</sup> Street to Van Buren Street; north on Van Buren Street to the beginning.

### **TRUSTEE ZONE NO. 3**

Beginning at the intersection of 6<sup>th</sup> Street and Main Street; east on 6<sup>th</sup> Street to Blaine Street; south on Blaine Street to Troy Street; east on Troy Street becoming State Highway 8 to the eastern district boundary; south then easterly and westerly along the district boundary to its intersection with US Highway 95; north on US Highway 95 becoming Main Street to Palouse River Drive; west a short distance on Palouse River Drive to Lenter Street; north on Lenter Street to Lauder Avenue; east on Lauder Avenue to Main Street; north on Main Street to the beginning.

### **TRUSTEE ZONE NO. 4**

Beginning at the intersection of the city limits of the City of Moscow and Old Pullman Road; northeast on Old Pullman Road to Perimeter Drive; northwest then northeast on Perimeter Drive to 6<sup>th</sup> Street; east on 6<sup>th</sup> Street to Greenhouse Road; north on Greenhouse Road to

Paradise Creek Street; east on Paradise Creek Street to Rayburn Street; north on Rayburn Street a short distance to Paradise Creek; northwest on Paradise Creek to the intersection with the Pullman Road; east on said Pullman Road to Line Street; south on Line Street to 6<sup>th</sup> Street; east on 6<sup>th</sup> Street to Elm Street; south on Elm Street to Sweet Avenue; east on Sweet Avenue to Main Street; south on Main Street to Lauder Avenue; west on Lauder Avenue to Lenter Street; south on Lenter Street to Palouse River Drive; west on Palouse River Drive to the point where the city limits departs to the north and Palouse River Drive becomes Sand Road; north then west then north then west on the city limits to the beginning.

#### **TRUSTEE ZONE NO. 5**

Beginning at the intersection of the west boundary (which is also the Idaho-Washington State Line) and the northern district boundary; easterly then southerly then east then south on the district boundary to its intersection with Showalter Road; west on Showalter Road to Hendrix Road; south on Hendrix Road to Robinson Park Road; west on Robinson Park Road to Lyon Road; north then west on Lyon Road to Crumarine Road; north then west then south on Crumarine Road to Frink Road; west on Frink Road to Moscow Mountain Road, south then west on Moscow Mountain Road to Herington Road; north on Herington Road to West Twin Road; west on West Twin Road to Mountain View Road; north on Mountain View Road to Idlers Rest Road; west on Idlers Rest Road to Foothill Road; south and west on Foothill Road to US Highway 95; south on US Highway 95 and Main Street to Sweet Avenue; west on Sweet Avenue to Elm Street; north on Elm Street to 6<sup>th</sup> Street; west on 6<sup>th</sup> Street to Line Street; north on Line Street to the Pullman Road; west on said Pullman Road to Paradise Creek; southeast on Paradise Creek to Rayburn Street; south on Rayburn Street to Paradise Creek Street; west on Paradise Creek Street to Greenhouse Road; south on Greenhouse Road to 6<sup>th</sup> Street; west on 6<sup>th</sup> Street to Perimeter Drive; south on Perimeter Drive to Old Pullman Road; southwest on Old Pullman Road to the city limits; east then south then east then south on the city limits to Sand Road; east on Palouse River Road (named Sand Road to the West) to Main Street; south on Main Street and becoming Highway 95 to the southern district boundary; west then south then north on the district boundary to the beginning.
