1. OPENING ITEMS

- A. The special meeting of the Board of Trustees of Moscow School District No. 281 was called to order at 6:30 PM, November 2, 2016 by Dawn Fazio, Chair, pursuant to Idaho Code Sections 33-506, 33-510 and 74-206 (1) (b). BE IT FURTHER RESOLVED that the student identified by Case 17-01 may request to appear before the Board no earlier than one week prior to the August 2017 board meeting for possible consideration for early re-entry into Moscow School District with documentation of completion of at least one credit, in a core subject, towards graduation requirements.

FURTHER RESOLVED that the student identified by Case 17-02 is not allowed access to the campuses of Moscow School District or attendance at any school events during the expulsion and

BE IT FURTHER RESOLVED that the student identified by Case 17-02 may request of the Superintendent by December 18, 2016 for re-entry into the Moscow School District on January 3, 2017, provided the student has made adequate progress in the student's subjects so the student is in a position to be successful with first semester finals. Additionally, if the student is granted re-entry, it will be on a probationary basis until the end of the 2016-2017 school year with the following conditions, passing all grades, no absences and no disciplinary incidents.

Trustee Frenzel moved that the Board approve Resolution 17-54 second by Trustee Schmidt. Motion carried 4-0-0.
